




# From the Desk of the Trustee



The disruptions caused by the Covid-19 pandemic are now recognized as a global catastrophe. Nowhere has that impact been felt more acutely than in local communities where prior impoverishment was further compounded. As we come out of the pandemic, we will as a society need to renew every effort at restoring a normal way of life, and the role of NGOs such as The Purnima Foundation in that process will be more important than ever.

The Foundation continued steadfastly during the past year in its program delivery within the various communities it serves. A particularly noteworthy part of our efforts was to educate rural communities on the nature of Covid-19, its transmissibility, and steps that can be taken to mitigate its spread. We have been highly encouraged by the attention that our outreach efforts created. In particular, the Foundation's active efforts at mask distribution was highly welcomed, with expanding demand throughout the past year.

The Foundation continued its march toward becoming a highly reputable organization in its other areas of activities as well. This Annual Report will provide detailed accounts of all current projects. The following is just a snapshot of our key activities.

- The Purnima Academy continued its efforts in creating opportunities to enhance the learning ability of students through special teaching in underprivileged areas. Our aim is to ensure quality of education and equal opportunity of learning is delivered to all students, which in turn creates appropriate future prospects for the next generation.
- The Foundation continued its outreach and advisory program toward adolescents on reproductive and sexual health, along with the use of quality and sustainable reproductive practices. The goal is to minimize child marriage and early pregnancy, and to reduce the incidence of STDs/RTIs.
- A micro-enterprise program (*Waste to Green*) has continued to flourish during the past year and created economic sustainability for many local women, including supplementary income.
- The Foundation continued its environmental protection activities through mass awareness, participation in the *Farmers for Earth* program, and the *Greening Kolkata* program. The flagship Waste *to Green* continues to elicit broad acclaim and interest.
- The Foundation's nutrition supplement program supported several thousand children and women by providing healthy food and beverages.

The approach we have taken is to focus on flexible and efficient action plans to create measurable outcomes for improving quality of life, enhancing empowerment (particularly among women), advancing child welfare and education, reducing poverty, improving health care, and safeguarding the environment. The one striking element in all of our efforts is that The Foundation encompasses community involvement and participation in all aspects of the project lifecycle to create local pride and ownership.

The continued dedication of our staff to the mission of the Foundation and helping our society is the very reason for the work you will see described in these pages, and the ebullient work in the year ahead.

The pandemic has created a myriad of challenges in the smooth operation of activities of The Purnima Foundation (TPF) in terms of funding, the performance of staff, and the consequent output of the existing programs. According to our review, we found that the Foundation has faced multiple challenges related to current programs in raising and mobilizing funds during the lockdown.

The pandemic has imposed an impediment on all aspects of the work of the Foundation- from running programs, planning finances, coordinating staff to collaborating with partners and stakeholders situated across the project areas. TPF was compelled to redesign the projects to respond to the rapidly changing landscape caused by COVID-19. In many situations, the project activities are put on hold due to implementation constraints and financial limitations. This has led to some major setbacks in the collective aims under the thematic areas of Sustainable Development Goals (SDGs). The second wave of COVID-19 early last year created an unprecedented crisis. With the changed context of the COVID-19 pandemic, the strategic approach of the Foundation was arranged in view of the additional needs, while coping with restrictions on travel, lockdown requirements, and health concerns.

The Foundation has conquest all odd situations and accomplished a measurable outcome of the intervention during the year. The Foundation has created a considerable impact in creating community awareness on safe practices and protection measures to prevent the pandemic of covid-19, educating deprived children, women empowerment through model initiatives in livelihood generation, spreading the messages of conservation of the environment, and community involvement in safeguarding the local environment, sensitizing the youth on safe reproductive and sexual health practices, creating self-reliance among transgender through successful micro-entrepreneurship initiatives and health and nutritional support to deprived children and community.



### Area of Intervention during 2021-2022







### 1. The Purnima Academy

The Purnima Academy has emerged as a centre of excellence in creating an opportunity to enhance the learning ability of students through special teaching in the underprivileged areas. The aim is to ensure the quality of education and equal opportunity of learning for all students to enhance their learning capability and appropriate direction for future prospects.

### 2. Waste to Green Energy: A Model Project

The key concept of the project is to create self-reliance among SHGs by exploring the sustainable livelihood opportunities in Waste to energy sectors, by enhancing the capacity of women, technology transferring and strong backward and forward linkages.

# 3. Microenterprise Development for Transgender Community

This project has created significant space for Trans community to involve in microenterprise development incorporating social security measures, and thereby creating self reliance and confidence.

### 4. The Green-TPF Programme

The Green-TPF (Environmental Awareness and Education) Programme of The Purnima Foundation is focused on raising the knowledge and sense of responsibility among community to respect, protect and preserve their immediate environment from further degradation.

# 5. Adolescent Reproductive & Sexual Health (ARSH)

The programme aims to improve adolescents' rights to access information on reproductive and sexual health and the use of quality and sustainable reproductive and sexual health services.

# 6. Mass Distribution Programme Emphasizing Nutrition Supplement

With the true intention of endorsing social-benefit delivery mechanism, the company is providing nutritional supplements in the form of healthy foodstuffs, beverages, cloths and educational materials to the beneficiaries.

### 7. ABHA Helpline

The Purnima Foundation's social helpline service, ABHA has helped in timely and efficient redressal of emotional and psychological problems faced by distressed school going children, dropouts, adolescents and adults.

### 8. Intervention to Combat Covid-19

To prevent the spread of the virus The Purnima Foundation has initiated "Break the Chain" a drive to raise awareness among rural and urban community on how they can stay safe with information on sanitation, personal hygiene, healthy diets, and social distancing.



# The Purnima Academy: Amader Pathshala

The Purnima Foundation has initiated a model project for educating unfortunate children of migrant labourers in brickfield areas of Durganagar village in Kulpi Block of South 24 Paraganas district. The brick kiln industries in West Bengal mostly depend upon both permanent and temporary migrant labourers. This type of migrated people forms a part of an unorganized labour force, which are poverty-stricken, and illiterate with no or minimum sustainable livelihood options in their native villages. The children of such workers are worst affected and vulnerable to all kinds of social deprivation. These underprivileged children are deprived of various basic amenities. It has been found that among various problems deprivation of educational opportunity is a crucial issue for the future growth of children.

The chance of receiving quality education and remedial educational support or even continuing their studies gets affected due to poor living conditions of the family, poor health, unfavourable home condition, and surrounding environment, frequent movement, unstable occupation of parents, and poor economic situation, and parental educational background.

The major objective of the programme:

- 1. To provide regular formal education to school going and pre-primary students
- 2. To create awareness among students and their parents on child rights (including the Right to Education), preventive health, and hygiene and make them realize that they too have access to govt. schemes and can avail the necessary services for their overall development
- 3. To retain students in the mainstream educational system
- 4. To involve them in extra-curricular activities (drawing, singing, dancing, and recitation)

### **Approach Adopted:**

- Community sensitization on the importance of education for children
- Enrolling children in formal and non-formal education centre of the Purnima Academy.
- Creating an equal opportunity for girls to encompass in the mainstream education system.
- Engaging qualified and experienced teachers to deliver quality learning support to the children.
- Creating space for formal education for school-going and pre-primary students.
- Exploring the talent of the students and grooming them for future growth.
- Special attention to slow learners and improvise the aptitude.
- Creating learning interest among students by introducing educational entertainment events.

### **TPF** became successful in:

- Providing individual care for each student in gaining knowledge of a particular subject
- Involving students actively in justifying their curiosities specifically in classroom subjects
- Introducing a practical application to grow the genuine interest of the class at the beginning of a lesson
- Enhancing learning skills by introducing different exercises of similar types
- Developing a comfortable learning environment to enhance the attentiveness amongst students
- Engaging students in both class and homework and checking it regularly
- Involving students in extracurricular activities in order to enhance their cognitive skill.




# Students admitted in formal category (Standard I to Standard VIII)




# Students admitted in non-formal category (Pre-primary)




### **Counselling for formal category students**




### Counselling for non-formal category students

### Overall performance rate among non-formal students
















# The Purnima Academy: Amader Aangina & Barnoporichov:

Every child has the right to access full-time formal school but innumerable ill-fated children as irregular and drop-outs are living in distressed and information compromised conditions in the rural areas of South 24 Parganas district. Therefore, The Purnima Foundation initiated an Alternative Education Project to help these children in framing their life with regular nonformal education. The Project is helping them to get information on child rights including the Right to Education, health & hygiene, and their overall well, and linking them to the surge in the formal education system of Basanti Block in South 24 Parganas. The Project is continuously trying to help them sustain their school education through remedial classes before and after school hours in the Alternative Education Centre.

- To provide regular non-formal education to dropouts
- To reconcile dropouts with schooling
- To provide remedial classes to dropouts after their school admission
- To create awareness among dropouts; on child rights (including the Right to Education), preventive health, and hygiene and make them realize that they too have access to govt. schemes and can avail the necessary services for their overall development
- To retain the dropouts in an educational institution in a sustainable manner.

# Reasons of absence among boys & girls in Centre:

- COVID -19 pandemic
- Lack of cooperation among parents
- Gender discriminative behaviour among few parents; they are not agreed to send their daughter to the education centre
- Children have to look after their younger siblings
- Occupational migration among parents. They often go to Kerala, Delhi, Mumbai, Gujarat, Orissa and Kolkata
- Children are engaged in domestic work, zari work, cycle repairing, fishing, stitching, agricultural work and brick making
- Due to illness; menstruation related illness, malnutrition, diarrhoea etc.
- Child marriage
- Child Labour in Park Circus, Dhulagarh, Kolkata and Delhi
- Distance of school from their residing place
- Dicey road condition during rainy season

- Conducting Home visit


### TPF became successful in:

- 1. Reconciliation of drop outs with schooling and regular educational structure
- 2. Identifying female students those who were staying out of school and bringing them under the purview of education system. Male female ratio is 34:46
- 3. Providing well- structured remedial classes to 184 students (both formal and non formal) belong to resource poor families
- 4. Helping irregular students to appear in Madhyamik Examination
- Creating opportunity to explore creativity among students
- 6. Ensuring health and well being of the local students
- 7. Bringing in the concept of child protection in local education systems can lead to essential changes in the ways schools function, children's behaviour when attending school and other educational institutions and the method in which teachers or school authorities interact with children.
- 8. Motivating local youths to involve into productive activity like overall development of local children. At least ten very efficient local youths have come forward to offer their service in the center.







### Irregular/Dropouts (April'21 to Dec'21)

### Combating Environmental Degradation and Creating Micro-enterprise for Deprived Women in Rural Areas

The Waste to Green Energy Programme was initiated as a major milestone in environmental protection by converting agro-waste to alternative energy through technological alternatives for the management of agricultural waste and creating livelihood opportunities for deprived women in the village. Secondly, the underneath goal is to reduce the emission of greenhouse gasses by the sustainable transformation of agricultural residue into a source of green energy. The women from the poor marginalized families are the targeted beneficiary of the project. Currently, 24 women are involved as direct beneficiaries and approximately 34 women as indirect beneficiaries from Kaorakhali village of Kultali block in South 24 Paraganas district. The goal of the project is to increase the utilization of biomass resources in developing and promoting more efficient and cleaner fuel substitutes and replacing the use of fossil fuels, which is a major cause of deforestation and environmental degradation.

From its inception, the project has faced various challenges that include a huge financial crunch, climatic challenges of frequent cyclonic events, and most significantly the crisis of Covid-19. All together have jeopardized the smooth operation and forced them to remain in a standstill situation for a longer duration. Over the last four months, the project has been invigorated with a strong strength of mind-set and upright determinations from the team of The Purnima Foundation and the inner willpower of the poor beneficiaries. The production unit is now in full working mode with its set goal and objectives. A total quantity of 21 ton briquettes has been produced during the time.

From the perspective of financial benefits of briquette production; with the current market rate of biomass briquette of Rs. 5500 per ton, a total sale of Rs. 1,15,500 has been acquired during the phase. Depreciating the cost of operation, a net profit of Rs. 80850 has been secured for the beneficiaries.

The project has reduced the burning tones of wastes substantially and the subsequent release of smoke and other pollutants. The project has a significant impact on the densification of bio-residues into briquettes as a promising step to improve their burning and handling properties.

The next plan is to increase the productivity of briquettes by nearly two to three folds through the introduction of a few devices and machinery like biomass drier, VFD device, and additional spare parts and increasing the time and days of work consistent with the increased establishment of markets.



### **Generating Livelihoods for Transgender**

Foundation has started working for the betterment of Transgender friends primarily living in South 24 Parganas, last year. We know that while there are specific provisions in the Transgender Bill that protect transgender interests by prohibiting discrimination in employment opportunities, the implementation of such provisions is a big challenge at the district level till date.

In South 24 Parganas, still, there is no such robust mechanism to safeguard transgender interests in the need of the hour. Equal opportunity for education and livelihood is not been ensured. The children who begin to identify as transgender often end up being ostracized from their families, peers, and teachers resulting in homelessness, illiteracy, and a complete lack of support system. To reduce livelihood vulnerability amongst the transgender friends in South 24 Parganas The Purnima Foundation has started one organic mushroom cultivation unit. This mushroom farming unit is taken as the source of generating a small-scale entrepreneurship that would give them income and respectful life.

In the last financial year, we have trained five transgender friends in mushroom farming. They are now ready to train other TG friends in South 24 Parganas who are associated with Pleqsus India Foundation. They are now experienced in spawn production, casing soil production, and substrate production. They know how to prepare ready to fruit bags and how to go for forward & backward linkage and marketing of products. After harvesting, fresh products are being marketed in local markets (Baruipur Kacharibazar). Products have had their demand in a few cafeterias and online organic vegetable stores. After undergoing this training on Oyster Mushroom Cultivation at our mushroom farming unit in Baruipur, a total of 10 transgender friends from different villages in South 24 Parganas could help them to ensure additional income by the utilization of available resources like paddy straw.

Encouraged by the success of Oyster Mushroom Cultivation with the limited number of TG friends during the first year, a total of ten transgender friends, mostly from South 24 Parganas have been enrolled in the program as refresher.







The Purnima Foundation has launched the Adolescent Reproductive and Sexual Health (ARSH) Programme in 2015 to reach out to both school-going and drop-out young adults (male-female) primarily living in urban slums and rural areas of West Bengal. The programme has tried to put focus on marginalized and underserved groups.

In the last year, the ARSH programme expanded the scope of adolescent health programming with inclusion of non-communicable diseases, gender-based violence, mental health, and substance abuse in its ambit.

The Drop-in-Centre under the programme acts as a youth-friendly corner that is a private space set apart from the rest of the community where young people can freely come and go without worrying about adult interactions. The programme has reached out to sixty adolescents primarily living in the Dakkhindari area near Ultodanga.

Aura Foundation as an implementing organization helped us a lot to retain these adolescents despite the COVID crisis. Former Councilor, Mr. Partha Verma appreciated the initiative and tried to provide support in order to make the program known to the community people.

Last year, our capacity-building training for peer educators include actions that build, strengthen and maintain the necessary competencies and resources needed to sustain or improve our adolescent reproductive and sexual health program for addressing health and psycho-social issues of the vulnerable and underserved adolescent population primarily living in shanties. Mainly the program focused on issues like peer education, reproductive and sexual health aspects of adolescents, adolescent rights and legal issues, growth and development during puberty, mental health problems, leadership skill development, and so on.

By conducting workshops we have introduced new ideas, and inspired participants to explore them on their own. It has promoted and illustrate actual process practice. It is a great way to teach hands-on skills as it has allowed learners to try out new methods and fall into a safe environment.









Health camps were organized at Uttor Durganagar village in South 24 Parganas through a sponsorship of Rupam Jana, a fellow of Jadavpur University. As many as 220 people from 8 villages were benefitted from the health camps. The objective of conducting the health camps was to create awareness of general health among the people, provide general health care services and counselling them on basic health care and hygiene. Dr. Arijit Shau (Paediatrician) and Dr. Biplab Das (General Physician) gave immense professional support to make these camps successful. They got overwhelming response from the beneficiaries.

Majority of the children and people who attended the health camps were suffering from very common but seriously neglected illnesses like diarrhoea, anaemia, acute flu, cough & cold, skin problems, high blood pressure and blood sugar etc. Doctors referred serious cases to the nearby district hospital.

Keeping the health and hygiene issues in mind sanitizer, face masks, cap, water purifying drops and bleaching power were being distributed among the beneficiaries.

All children were provided with medicines, vitamin tonics and adolescent girls got iron tonics. Children suffering from diarrhoea were given ORS. Health camp duos were immensely appreciated by local people.

The eight years of ABHA Helpline has been a journey with mosaic of experiences, of achievements and challenges.

ABHA Helpline has made a remarkable progress in making the helpline and its activities relevant and appropriate to reach out to people in distress.

### Holding the Hand: A Collaborative Distribution Initiative



Since the inception, The Purnima Foundation comprehended the need of nutritional supplements, hygienic care, and clothing for the deprived children in the society. The Foundation explored the supporting organisation to accomplish the dream. The Dabur India Limited, Raja Udyog Limited and many other organisations and individuals came forward and vowed to create success of the goal. The las few years has been a journey of appreciation for our "Holding the Hand" program. We are continuously seeing it turn into an allegory for addressing marginalized needs. In this relentless effort, Foundation stands by people living in rural areas and urban slums who are suffering from resource compromised conditions.



With generous support from Onaya Foundation; under the flagship of its Katran initiative (making clothing from scrap dress material) we have distributed new dresses to more than seventy-seven girls at the precinct of The Purnima Foundation.



The Foundation is successful in bringing a smile to the face of one thirty-five little angels in Amader Aangina and Barnoporichoy, situated at a small hamlet in Basanti of South 24 Parganas. We distributed cupcakes among them with support from Raja Udyog Private Ltd.



The Foundation conducted an awareness generation event on personal hygiene and nutrition Raja Makhkhan Bite biscuits have been distributed amongst one thirty-five children at Amader Aangina and Barnoporichoy centre in Basanti of South 24 Parganas District.

# **Holding the Hand: A Collaborative Initiative**





In memory of Late (Mrs.) Rekha Aich, her son Dr. Indranil Aich donated ten pairs of benches for the children in Amader Aangina and Barnoporichoy centre at Amratala village in Basanti of South 24 Parganas district.



A total number of fifty children of migrant labourers (associated with brickfields in Kulpi) were fed glucose water by our project staff in Amader Pathshala. Face masks and caps were also being distributed among them



The Purnima Foundation distributed Dabur glucose to two hundred and twenty-six children in need who are associated with Kalugachi Swami Vivekananda Seva Sangstha in North 24 Parganas



The Purnima Foundation distributed face masks to transgender friends who are associated with KOSHISH in Kolkata



In collaboration with GOONJ, under the flagship of its Dignity for Work and Urban Implementation Program, the Foundation distributed domestic kits to one hundred women who took part in a cleanliness drive that was conducted in the Jhaldar Math slum area. 

### **Multi-Sectoral Intervention**



**Water ATM** is installed by Enactus in technical collaboration with The Purnima Foundation at Shamshernagar in Hingalganj block of North 24 Parganas. The project aims to produce a product that will make purification of contaminated water easy and efficient to use.

Enactus is a global community that unites students, academia, business and industrial community to use their skills to benefit society by creating safe drinking water opportunities for needy people.





The Project Coordinator (The Purnima Academy, Amader Aangina), Sachin Naskar took part in an awareness program on the prevention and control of COVID infection. The program was organized by Basanti Kishan Swaraj Samity. Sachin joined the program as a resource person.

The Foundation organized one meeting with farmers who are hailed from Basanti block of South 24 Parganas on smart farming techniques using organic fertilizers, pesticides and fungicides. Discussed on crop rotation and multitier farming techniques.

The children in Amader Pathshala enjoyed a lot and spent a fun filled day with their teachers. One of our well wishers, Mrs. Shibani Chakraborty gave a small treat to the children in the memory of her deceased husband.



The Purnima Foundation conducted one career awareness camp collaborating with Anudip Foundation for vulnerable women and girls at Amratala village in Basanti of South 24 Parganas in collaboration with our organization. Our coordinator, Sachin Naskar at Amader Aangina centre organized the camp.






